Drawback In Legalized Training Organization

Legal education in India is regulated by multiple organizations such as University commission (UCG), Bar council of India (BCI), The government and respective authorities of the respective universities. Because of countless reasons the quality of the legal education didn't get satisfactory. To make it satisfactory Bar council of India made many changes in the curriculum of the universities and established national law university for better result. 1st National Law University was established in Bangalore in year 1986. Even the changes are not sufficient to meet the challenges of 21st globalization. There are some drawbacks that are mentioned below which needs to be rectified:-

1. Outdated syllabus

Society changes time to time because of which all the things get changes weather in legal sector, economic sector or political sector. Society is bound to change so that people adopt new things and new things can be learnt by people.

If we talk about legal education sector, many schools and collages often go with the outdated curriculum which often fails to keep pace with the evolving legal environment. Many law schools teach those subjects which are no longer relevant and due to which we remain behind in the society because the society has progressed and we are studying the outdated syllabus which is not relevant anymore.

In many law schools, faulty mostly focuses on learning legal provisions rather than critical thinking and helping student with problem solving skills which can affect their learning process and affect their future.

3. Poor Infrastructure

There is urgent need to do reform in legal education sector because many law schools are opening without having sufficient quality and excellence to run the law school, which deteriorate the conditions of law education sector and future of upcoming lawyers.

Manubhai Vashi vs. State Of Maharashtra-Hon'ble Supreme Court held that ---the legal education should be able to meet the ever growing demands of the society and should be thoroughly equipped to cater to the complexities of different situations.

In Inamdar Vahab Badasha and Ors. Vs. Symbiosis Society's Law Colleges- In this case bar council of India said that it is very difficult for students to enter into Law College with such a high cut-offs. The prescribed minimum qualification therefore has a rational nexus to the purpose sought to be achieved. We also do not feel that; the percentage fixed is in any manner arbitrary. It is reasonable and more so in view of the general pattern of percentage of marks generally obtained at the qualifying examinations.

In 2015, meeting held by Bar Council of India in Chennai, BCI chairman Manan Kumar Mishra said that "30% of all lawyers in India are fake, holding fraudulent law degrees". Reason behind this is out-dated curriculum, lack of skills which are very essential in law practice. Nowadays law graduates are book worms, they don't have sufficient practical knowledge because their university don't focus on skills and practical knowledge and don't help the students to cope up with current legal affairs.

Some summarise points and steps that should be taken for the betterment of the legal education system mentioned below:-

 Out-dated curriculum needs to be changed according to the time and changes in the world.
The curriculum must be followed of 3 year course syllabus.

Curriculum must include international law so that students get the knowledge about it so that they get able to participate in such international level of competitions.

- Practical knowledge should be increased and skills should be improved such as writing skills, speaking skills. These skills will boost the confidence in the student and will help children to mould themselves and know their importance and role in the legal field.
- Infrastructure needs to be improved such as huge libraries in law universities, smaller classroom so that there will be limited number of students to teach so that teacher can concentrate and pay attention to every student.
- There should be a very good and friendly relation between Student and teacher. This is the biggest drawback which needs to be changed.
- Moot courts, court visit, research paper writing, debates competition needs to be done in universities for booting student's confidence and providing them a stage so that they can learn.

In many law universities they do organise moot courts competitions where international schools and universities are also participants. So universities should encourage the study of international law so that future lawyers do have the knowledge of international law.

Stumbling block in Legal field

The legal sector is a multi-billion dollar industry with extensive opportunities. Legal practice is one of the most highly paid professions and most respected professions in the world.

The legal sector includes professions like litigation, judicial services, solicitor, corporate lawyer, legal advisors, and so on. In this profession, the person has to be a king of practical knowledge also theoretical knowledge.

There are many stumbling blocks in the path of the legal profession because there is a lot of writing effort, research work which makes the process slow, and so on. After covid-19 it's been onerous to get into the legal profession.

1. Ratio of judges and cases

There is less budgetary allocation around 0.08 - 0.09% of the GDP in the judiciary system. There are very less judges in the ratio of the currently pending cases ie India.

A maximum number of cases are being continued for more than a year, now it's been very common for the cases to be continued in the court for more than a year, the reason behind it is this ere a very less no. of judges in comparison to the cases.

How many cases a judge can hear, after all, he is also a human being, to decrease the number of pending cases the government should appoint more judges and encourage people to study for the judiciary exam for the betterment of society.

2. Delay in justice
